Product name: COPPER/ZINC LR TABLETS

2. COMPOSITION / INFORMATION ON INGREDIENTS

Ingredient 1: DYE, BUFFER AND FILLER MATERIAL >90%

3. HAZARDS IDENTIFICATION

Main hazards: No significant hazard.

4. FIRST AID MEASURES (SYMPTOMS)

Skin contact: There may be mild irritation at the site of contact.
